HOW DO WE COLLECT INFORMATION FROM YOU?

We obtain information about you when you use www.compcofire.co.uk, for example, when you complete our Contact Form and/or when you complete the Feedback Form or submit your CV.

We collect your data when we seek your views or comments on the services we provide, or notify you on changes to our services. We may also collect your data when we send you communications which you have requested and that may be of interest to you.

WHAT TYPE OF INFORMATION IS COLLECTED FROM YOU?

The personal information we collect might include your:

- Name
- Address
- Email Address
- IP Address

We may also collect information regarding what pages on www.compcofire.co.uk are accessed and when.

USE OF 'COOKIES' WEBSITE RECORDING

Like many others, Compco Fire Systems use Cookies. 'Cookies' are small pieces of information sent by an organisation to your computer and stored on your hard drive to allow www.compcofire.co.uk to recognise you when you visit. They collect statistical data about your browsing actions and patterns and do not identify you as an individual. For example, we use Cookies to store your country preference. This helps us to improve www.compcofire.co.uk and deliver a better more personalised service. It is possible to switch off Cookies by setting your Browser Preferences, however turning Cookies off may result in a loss of functionality when using www.compcofire.co.uk.

Google Analytics:

These Cookies are used to collect information about how visitors use www.compcofire.co.uk. We use the information to compile reports and to help us improve the site. The Cookies collect information in an anonymous form, including the number of visitors to the site, where visitors have come to the site from and the pages they visited.

These are Google Maps 'Third Party Cookies', which are unique identifiers to allow traffic analysis to Google Maps.

HOW IS YOUR INFORMATION USED?

We may use your information to:

- Contact you regarding queries raised in the Contact Form/Feedback Form
- Seek your views or comments on the services we provide
- Notify you of changes to our services
- Send you communications which you have requested and that may be of interest to you. These may include information about campaigns, appeals, other fundraising activities, promotions of our associated companies' goods or services
- Process a job application

We review our retention periods for personal information on a regular basis. We are legally required to hold some types of information to fulfil our statutory obligations. We will hold your personal information on our systems for as long as is necessary for the relevant activity, or as long as is set out in any relevant contract you hold with us.

WHO HAS ACCESS TO YOUR INFORMATION?

We will not sell or rent your information to third parties. We will not share your information with third parties for marketing purposes.

We may pass your information to our third-party service providers, agents, subcontractors and other associated organisations for the purposes of completing tasks and providing services to you on our behalf (for example to process donations and send you mailings). However, when we use third party service providers, we disclose only the personal information that is necessary to deliver the service and we have a contract in place that requires them to keep your information secure and not to use it for their own direct marketing purposes.

Please be reassured that we will not release your information to third parties beyond the company for them to use for their own direct marketing purposes, unless you have requested us to do so, or we are required to do so by law, for example, by a court order or for the purposes of prevention of fraud or other crime.

We may transfer your personal information to a third party as part of a sale of some or all of our business and assets to any third party or as part of any business restructuring or reorganisation, or if we're under a duty to disclose or share your personal data in order to comply with any legal obligation or to enforce or apply our terms of use or to protect the rights, property or safety of our supporters

and customers. However, we will take steps with the aim of ensuring that your privacy rights continue to be protected.

RIGHT TO ERASURE

GDPR introduces a right for individuals to have personal data erased. The right to erasure is also known as 'the right to be forgotten'. Visitors/users of www.compcofire.co.uk can have a copy of all records of their personal data and to ask for such data to be erased.

We will ask for proof of identity before, and data can be shared or erased. We will respond to any requests for erasure within 1 month or receipt of the request. We have security precautions in place to protect the loss, misuse or alteration of your information when you give us personal information.

We take steps to ensure that it's treated securely. Any sensitive information (such as credit or debit card details) is encrypted and protected with the following software 128 Bit encryption on SSL. When you are on a secure page, a lock icon will appear on the bottom of web browsers such as Microsoft Internet Explorer.

Non-sensitive details (your email address etc.) are transmitted normally over the Internet, and this can never be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, we cannot guarantee the security of any information you transmit to us, and you do so at your own risk.

Once we receive your information, we make our best effort to ensure its security on our systems. Where we have given (or where you have chosen) a password which enables you to access certain parts of www.compcofire.co.uk, you are responsible for keeping this password confidential. We ask you not to share your password with anyone.

PROFILING

We may analyse your personal information to create a profile of your interests and preferences so that we can contact you with information relevant to you. We may make use of additional information about you when it is available from external sources to help us do this effectively.

We may also use your personal information to detect and reduce fraud and credit risk.
